# COMMERCIAL PILOT LICENCE

## Conditions of Issue

1. The holder shall not give dual flying instruction unless authorized.
2. The licence may be suspended or cancelled for failure to observe provisions of the Air Regulations or for cause.
3. The privileges of the holder of a valid Commercial Pilot Licence shall be:
  - (1) To exercise all the privileges of a Private Pilot.
  - (2) To act as pilot-in-command in any aircraft engaged in commercial operation other than scheduled commercial air transportation;
  - (3) To act as pilot-in-command in non-scheduled commercial air transportation in any aircraft having a gross weight not exceeding 12,500 pounds.
    - (a) Under VFR
    - (b) Under IFR, if he holds an instrument rating, and not carrying passengers for remuneration.
    - (c) Provided that he shall not exercise this privilege by night unless, within the ninety days immediately preceding night flight, he has carried out not less than five take-offs and five landings by night.
4. To act as co-pilot in scheduled commercial air transportation in aircraft required to be operated with a co-pilot, provided that for flights under IFR, he holds an instrument rating.
5. A medical examination will be made by a medical officer approved by the Minister.
